July 21 Step Workshop Committee Meeting:

The committee is proposing a panel discussion workshop to present steps 1 through 3 and a meal.

The following is the initial format proposed by the committee:

1. The workshop will cover steps 1 through 3.
2. There will be (4) host groups
 - i. Carry & Sharing
 - ii. Simply AA
 - iii. AA the Family Afterward
 - iv. Primary Purpose 12:30 Men's group
3. Panels
 - a. There will be (1) panel of (4) people for each step.
 - b. Each of the host groups will provide (1) person for each panel.
 - c. A person can be on multiple panels.
 - d. We will need (1) female for each panel.
4. Format
 - a. Each step will be allowed (1) hour.
 - b. There will be a moderator/facilitator for each step provided by one of the host groups.
 - c. 5-10 minutes for each panelist will have to discuss how they worked the step.
 - d. 20 minutes for questions and answers. (moderator will have prepared questions if required).

 4. Misc \$75

 - a. Several locations are being investigated and will be discussed at the next committee meeting.
